Sub: Payment of electricity bill under protest.

The above said Service connection was obtained from the electricity department for the construction work in the year 2008 and the total construction work has been completed in December 2012 since then there was no major usage of power. The meter was stop working since September 2014. A complainant was lodged in the month of November 2014 to replace the metre instead of replacing the metre Dept people has disconnected the power connection in the month of March 2015.

Suddenly a bill for Rs.1,91,636/- (Copy enclosed) was received of the above referred service connection. In this connection the total billing data was obtained from the Department for the period September 2008 to February 2015 of the above said service number (copy enclosed). The data is clearly showing the monthly power consumption details since October 2008 to May 2012 and thereafter Dept has not taken metre reading every month regularly and also there is no mention of opening/ closing metre readings and no. of units consumed and has charged a sum of Rs.1,46,170/- at a time in the month of November 2014 by showing a consumption of 16,194 units in the month of November 2014 and after that Department has levied minimum monthly charges and have issued bill for the above said amount of Rs. 1,91,636/-. Charging these many units for the metre which was not in working is incorrect. We made several requests to the department to levy the bill as per actual metre reading but our requests have not considered by the department.

Please note that the average power consumption per month from the year Oct' 2008 to May 2012 is as follows (details are enclosed herein).

We have requested the department to dismantle the service connection vide our letter dated 9<sup>th</sup> February 2016 but they did not disconnected it and is still charging monthly minimum charges for the metre which was under disconnection. The bill amount has reached from Rs. 1,91,636/- to Rs.2,32,323/- (reference No.5) up to February 2016 due to the addition of monthly minimum charges and the electricity department regularly forcing us to pay the bill amount otherwise they will disconnect other service connections and have disconnected other service connections twice. To avoid sum type complications we have paid a sum of Rs.1,00,000/- (Rupees One Lakh only) on 24.03.2016.

Please note that the department has given credit in the month of March 2016 Rs. 45,970/- and in the month of April 2016 Rs. 13,928/- and the balance bill amount left is Rs. 76,474/-. Due to Department pressure we are paying the balance amount of Rs. 76,474/- (Rupees Seventy Six Thousand Four Hundred and Seventy Four only) under protest.

We request you to levy the charges as per actual metre reading from June 2012 and give credit to our account to refund the excess paid amount at the earliest.

Please issue receipt for the same.
