- G. The custody of gold jewellery and silver articles thus got passed onto Soham upon death of his father Satish Modi.


The WILL and desire of his mother Smt. Tarulata for the distribution of articles amongst her grandchildren and daughters of Soham is being done now.

This Memorandum now therefore records the distribution of the estate of Late Smt. Tarulata Modi as follows:


Nidhi Modi and Nisha Modi has been given 400 gms of gold/gold jewellery and 2kgs of Silver/silver articles each.


