Dear Mr. Anand Sagar,

You have made preliminary designs for villas for our new project known as Silveroak Villas situated at Cherlapally. We intend to standardize designs of villas across several projects. The designs for Silveroak villas will be used with minor changes for several other projects. The same designs shall be immediately used for Nilgiri Estates Phase II.

Keeping in mind the above I propose the following structure for consultancy charges.

a. Consultancy charges for design of villas - Rs. 10,000/- per villa for Silveroak Villas and Rs. 5,000/- per villa for other projects using similar designs.

b. Rs. 10/- per sft for design of clubhouse (excluding parking floors - no charge).

c. Apartment block of EWS/LIG units - Rs. 5/- per sft (excluding parking floors - no

d. Rs. 50,000/- per acre for design of layout and amenities.

e. Service tax shall be paid extra and TDS shall be deducted.

f. Payment terms: 25% in 3 installments till preparation of sanction plans. 25% in 3 monthly installments on receipt of sanction. Balance 50% in 8 quarterly installments

starting 3 months from sanction.

g. All drawings like working drawings, electrical drawings, bathroom layouts, elevation drawings, compound wall, main gate, security kiosk, etc., related to the clubhouse and villas must be completed within 6 weeks from sanction. Once sanction fees are paid work on these drawings can be started. It may take 4 weeks to release sanction after payment of sanction fees. Therefore, 10 weeks will be available for completing these drawings.
