This petition coming before me for hearing in the presence of  
Sri.D.Mohan Reddy, Advocate for the petitioner and of Govt. Pleader for  
Respondent and having stood over for consideration till this day this  
court made the following:

ORDER

This is a reference under section Land Acquisition Act with regard  
to the acquisition of land of 0-32 gts in Sy.No.4/3 in Uppal Mandal of  
Mallapur village, an award in File No.D/219/98, dated 4-6-1999 on the  
ground that the claimant as per record, Chandu Bai did not file any  
application and she died and the claim made by her grand son  
Narasimha Rao based on a Will deed has to be determined by the court.  
An amount of Rs.5,43,247/- is in the court deposit towards  
compensation for the land acquired. On the issue of the notice, the  
claimant filed a claim statement pleading that the original pattadar  
Chandu Bai was his grand mother and she bequeathed the suit schedule



property to him under a Will deed dated 9-6-1992 and she expired on 23-8-1992. Thus, he asserted the title over the land acquired. Though he took up a further plea disputing the valuation fixed by the Land Acquisition Officer and claimed that he is entitled for compensation at the rate of Rs.400/- instead of Rs.70/- per square yard as fixed by the Land Acquisition Officer, this being a reference only under Section 30 of Land Acquisition Act, that plea cannot be considered in this reference.

2. In order to establish his right over the land as a legatee of original pattedar Chandu Bai the claimant examined his father as PW-1, who is the GPA holder of the claimant, as can be seen from the Ex.A-1. He has also filed the Will Ex.A-2 under which he claim title, Ex.A-3 is the ULC certificate and Ex.A-4 to Ex.A-12 are the pabani accounts and Ex.A-13 is the ROR proceedings.


3. To prove the Will, he examined PW-2 one of the attesters of Ex.A-2 Will. His evidence would clearly show that the testator executed the Will deed in hale and healthy and in sound disposing state of mind in his presence and he attested the same and the testator as seen him attesting the document. He has also deposed that another attester Venkat Reddy was also present at the time of execution of A-2. The evidence of PW-2 would clearly prove the Will made by the original pattedar in favour of the claimant.



4. As a matter of fact, even Ex.A 13 ROR proceedings, this claimant is recognized as pattaedar over the land in Sy.No.4/1 to an extent of Ac.6-00 gts apart from other lands. The pahani would also show that the land is registered in the name of the claimant. In the light of oral and documentary evidence by the claimant it is clearly established that by virtue of EX.A1 Will from his grand mother he acquired the rights over the land and consequently, he is entitled to receive the compensation.

5. Accordingly, this reference is answered, recognizing the claimant Narsimha Rao as the owner of the land and entitled to receive compensation.
