



That the said attorney is authorised to Manage and sell the agricultural lands by entering into sale agreements with the intending purchasers, for which purpose submit necessary applications, documents, to swear to affidavits, sign petitions or any other documents and to submit the same before the concerned authorities i.e., for obtaining necessary permissions and to execute and register the Sale Deed(s) in favour of the intending purchasers by presenting the same before the Registering Authority by receiving sale considerations, and deposit the same in the Bank on the principles account.

To file suits or applications or commence other proceedings in civil, Criminal from our behalf in respect of or arising out of the said property and to prosecute the same and for such purpose to sign, execute or attest plaints, petitions, appeals or other documents that may be necessary therefore and to verify the same, to swear to Affidavite and to compromise, refer to arbitration, binding himself on oath to accept service and defend any suit or other proceedings that may be filed against us in respect of the said schedule of property and to prosecute the claim or defend in the court of appeal or original side, or before any officer, whether in civil, criminal, revenue courts, Revenue Officers or Tribunal Offices or before Income Tax Authorities and for such purpose to appoint any advocate, pleader, solicitor or Agent.




