This is a case filed by One Sri Mohd. Rahman Ali s/o. Mohd. Vazeer Ali Saheb Bakshi for resumption of Inam lands U/s.44 of Tenancy and Agricultural Lands Act, 1950 Read with Section 4(4) of Andhra Pradesh (Telangana Area) Inam Abolition Act, 1955 for Sy.No.93, 94 and 95 situated at Mallapur village of Uppal Circle of Hayathnagar taluq.

Notices were issued to the Protected Tenants (Respondents) and they contested the case and filed (Objection) counter.

The petitioner has filed the following documents in support of his claim:

1. Chowfasla of the Inamdars for the year 1970-71 for the lands situated at Mallapur village.
2. Certified copy of Tenancy record for the suit lands.
3. Certified copy of Munthakab issued by Commissioner of Survey, Settlement and Land Records, A.P., Hyderabad.
4. Photo copy of Regd. Document No.1913 of 1965 dated. 20-12-1965 pertaining to the partition deed between their three brothers.
5. Photo copy of order in O.S.No.376 of 1981 dt.23-4-1981.

During the course of trial both the petitioner and respondents have come to compromise and they have filed the compromise deed. Both the parties have attended the court on 14-8-1981 and they stated that the compromise deed was written with their consent and they agreed with the terms mentioned in the compromise deed and they themselves signed on the compromise deed. In view of the above facts the compromise deed has been accepted and the following order is passed:

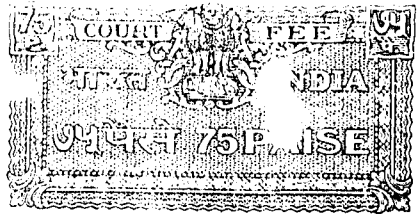
O R D E R :-

The lands bearing Sy.Nos.93 (2-02), 94 (2-09) and 95 (21-01) is all measuring totally ac.25-12 guntas situated at Mallapur village, Uppel Circle of Hayathnaga taluq are the Pan-maqtha Dasthagardan Inam land stands in the names of three brothers M/s. Azmath Ali, Rahman Ali (petitioner) and Mohd. Ali all brothers. According to the family partition deed between the above three brothers (Inamdars) in the year 1965 the suit lands have come to the share of the petitioner. Petitioner has also filed the registered partitions deed bearing No.1913 of 1965 dated.20-12-1965. All the suit lands are in the possession of the protected tenants.

As per the compromise deed the petitioner Sri Rahman Ali is entitled to get Patta Rights over an area of Ac.12-32 guntas out of the total area of Ac.25-12 guntas in Sy.No.95 and the protected tenants are

entitled to get the patta rights over the Sy.No. 93 and 94 measuring Ac.4-11 guntas and the balance area of Ac.8-09 guntas in Sy.No.95. The Protected tenants have also agreed to relinquish all their rights over the **lands** which are gone to the share of the petitioner as per compromise deed. It is further ordered to issue Occupany rights to both the parties on the Sy.Nos. mentioned above.

This case is accordingly disposed off with the above orders.
