This is an appeal filed by U/s 24 of A.P. (T.A) Abolition of Inam Act 1955, aggrieved by the orders passed by the Revenue Divisional Officer Ranga Reddy East Division in file No.J/568/2000 dated: 7.5.2003 in respect of the land bearing Sy.Nos.93, 94, & 95 to an extent of Ac. 2-02 gts, 2-09 & 11-12 gts respectively situated at Mallapur village of Uppal Mandal.

The brief facts of the case are that the respondents have filed application in form I for grant of Occupancy Rights Certificate in Sy.No.93, 94 & 95 admeasuring Ac.2-02, 2-09 & 11-12 gts respectively of Mallapur village Uppal Mandal, Ranga Reddy District. During the enquiry the appellant herein has also filed petition in form I claiming half share along with the respondents in the above said Sy.Nos. After due enquiry the Inam Tribunal / Revenue Divisional Officer East division has issued Occupancy Rights Certificate in favour of the respondents in Procg.No.J/7156/96 dated: 6.9.97 while rejecting the claim of the appellants. Aggrieved by the issuance of said certificate the appellants preferred an appeal before this court vide case No.F1/6908/97 wherein it was ordered to set aside the order of Revenue Divisional Officer on 29.1.2000 and remanded back the matter for fresh enquiry. Again the Revenue Divisional Officer confirmed the Occupancy Rights Certificate on 7.9.1997 stating that the appellants have not established their possession over the land as on 1.11.1973.

Aggrieved by the said certificate the appellants again filed the present appeal. The case was taken on record. Notices were issued to both the parties fixing the date of hearing on 01.7.2003.
