ORDER

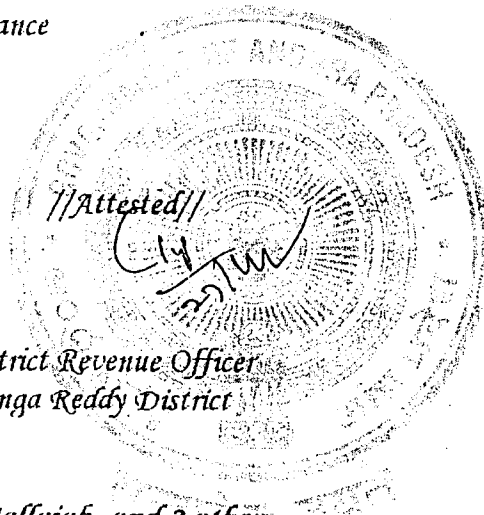
Government vide G.O.Ms.No. 293, Revenue (DA) Department, dt. 31.05.2002 have issued instructions to the possibility of selling valuable Government lands in public auction to avoid additional burden on Government for construction of Government Buildings. Accordingly a notification has been issued on 4.09.2003 & 5.09.2003 in the local News Papers for conduct of auction on 17.9.2003.

The auction was knocked down in favour of Sri M. Venu S/o.M. Mallaiah and 2 others, who is the highest bidder in the open auction and the bid amount is Rs.97,80,000/- (Rupees Ninety seven Lakhs Eighty thousand only) for the land bearing Sy.No.176 admeasuring 3-12 acres, situated at Nagaram Village of Keesara Mandal, RR District.
