ORDER


Through the reference 1<sup>st</sup> Cited orders have been issued allotting the Auction land bearing Sy.No.176 to extent of Acs.3-12 gts. Situated at Nagaram Village of Keesara Mandal Ranga Reddy District in favour of highest bidder Sri M. Venu S/o. M. Mallaiah, Sri G. Madhusudhan S/o. Late G. Sattaiah, Sri K. V. Rama Rao S/o. Gopal Rao since the said bidder has been remitted the entire auction amount of Rs.97,80,000/- and the Mandal Revenue Officer Keesara has been directed to demarcate and fix up the boundaries of the said land and handover possession of Sy.No.176 to extent of Acs.3-12 situated at Nagaram Village of Keesara Mandal to the bidder and incorporate the same in the Revenue records and report compliance.

Through the reference 2<sup>nd</sup> cited the Assistant Director, Survey & Land Records Ranga Reddy District reported that after demarcation of boundaries, the extent of land in Sy.No.176 situated at Nagaram Village of Keesara Mandal Ranga Reddy district is comes as Acs.3-04 gts. instead of Acs.3-12 gts. and requested to treat the extent of Sy. No.176 as Acs.3-04 gts.

In view of the above land bearing Sy.No.176 to an extent of Acs.3-04 gts. Situated at Nagaram Village of Keesara Mandal is hereby allotted in favour of highest bidder Sri M. Venu S/o M. Mallaiah, Sri G. Madhusudhan S/o late G. Sathaiah and Sri K.V. Rama Rao S/o Gopal Rao.
