## LEASE AGREEMENT

This LEASE AGREEMENT is made and executed at Secunderabad, on this the 15st day of February, 2008 by and between:

1. MR. SYED MEHDI, S/o. MR. SYED MOHAMMED, aged about 46 years, resident of 1-5-16/2/1, Musheerabad, Hyderabad – 500 020.

2. MRS. RAZIA BANO, W/o. MR. SYED MEHDI, aged about 36 years, resident of 1-5-16/2/1, Musheerabad, Hyderabad – 500 020,

represented by their Specific Power of Attorney Holder M/s. Modi Properties & Investments (P) Limited, having its registered office at 5-4-187/3 & 4, III floor, M. G. Road, Secunderabad, represented by its Managing Director Mr. Soham Modi, hereinafter jointly referred to as the "LESSORS" and severally as LESSOR No. 1 & LESSOR No. 2 respectively (which term shall mean and include whenever the context may so require its successors-in-interest);

MR. K. VENKATESHWARULU, S/o. MR. ADISESHAIAH, aged about 38 years, resident of New No. 27, (Old No 18), 67<sup>th</sup> Street, Jafferkhanpet, Ashok Nagar, Chennai – 600 083. Hereinafter referred to as the "LESSEE" (which term shall mean and include whenever the context may so require its successors-in-interest);

WHEREAS the LESSORS are the absolute owners of the duplex bungalow known as Furqan Villa, consisting of 4 bedrooms, drawing, dinning, kitchen and servants quarter, situated at Plot No. 141, forming a part of Survey No. 74/3, admeasuring about 2,250 sft. of built-up area on 233 sq. yds. of land at Ravi Co-operative Housing Society, Marredpally, Secunderal ad. The LESSEE has requested the LESSORS to grant on lease the above said bungalow and the LESSORS agreed to give on lease on the terms and conditions specified as hereunder:

WHEREAS the LESSORS have entered into a property management agreement dated 15th February, 2008 with M/s. Modi Properties & Investments (P) Limited, represented by its Managing Director Mr. Soham Modi for the management of the said building, to negotiate and enter into lease with prospective tenants, collect rent, amenities and maintenance changes, to undertake regular repairs and maintenance of the building, etc. The LESSORS have also given a Specific Power of Attorney to M/s. Modi Properties & Investments (P) Limited, represent a by its Managing Director Mr. Soham Modi, dated 15<sup>th</sup> February, 2008 to enter into lease, for collection of rent, amenities and maintenance charges, for issue of receipts etc.

Know all men by these presents that in pursuance of the rent hereby reserved and the convenients agreed specified hereunder the LESSOR doth hereby grant and the LESSEE doth hereby taken on lease the duplex bungalow known as Furqan Villa, consisting of 4 bedrooms, deving, dinning, kitchen and servants quarter, situated at Plot No. 141, forming a part of Survey No. 74/3, admeasuring about 2,250 sft. of built-up area on 233 sq. yas. of land at Ravi Co-sperative Housing Society, Marredpally, Secunderabad more particularly described at the foot of this document, on the following terms and conditions.

KNOW ALL MEN BY THESE PRESENTS THAT in pursuance of the rent hereby reserved and the covenants agreed specified hereunder, the LESSORS doth hereby grant and the LESSEE doth hereby taker on lease the duplex bungalow known as Furgan Villa, consisting of 4 bedrooms, drawing, dinning, kitchen and servants quarter, situated at Plot No. 141, forming a part of Survey No. 74/3, admeasuring about 2,250 sft. of built-up area on 233 sq. yds. of had at Ravi Co-operative Housing Society, Marredpally, Secunderabad, more particularly accounted at the foot of this document, on the following terms and concitions: -

1) The LESSEE shall pay a rent of Rs. 10,000/- (Rupees Ten Thousand Only) per month exclusive of Water & Electricity consumption charges and subject to the clause pertaining to the enhancement of rent contained hereunder as per the following details:

Rent payable to LESSOR No. 1 -Rs. 5,000/-Rent payable to LESSOR No. 2 -Rs. 5,000/-

2) The LESSEE shall pay an amount of Rs. 60,000/- (Rupees Sixty Thousand C. ) as Security Deposit as per the details given below, which shall be refunded by the LESSCAL to the LESSEES at the time of vacating and satisfactory handing over of the premiets. The LESSEE shall not be entitled to any interest on the Security Deposit lying whit the LESSORS.

Deposit payable to LESS 3R No. 1 -Ps. 30,000/-Deposit payable to LESSOR No. 2 -Rs. 30,000/-

- 3) The lease shall be for a period of 1 year, commencing from 15th February, 2008. This agreement of lease between the said LESSORS and the said LESSEE can be terminated with an edvance notice in writing of three months.
- 4) The LESSORS and the LESSEE hereby undertake to execute a regular Lease Deed if .r. when called upon by either of the parties to do so at any time during the currency of the Lease Agreement.
- 5) The expenses of Stamp Duty and Registration charges of this agreement in duplicate other incidental expenses shall be borne by the LESSEES in full. Mul

#### THE LESSEES HEREBY COVENANTS AS UNDER:

- 1) The LESSEE shall pay the rent regularly per each month on or before the 7<sup>th</sup> day of the succeeding month to the LESSORS.
- 2) The LESSEE shall pay and bear the Water & Electricity consumption charges, including any additional consumption deposit that may be levied from time to time, apart from the rent.
- 3) The LESSEE shall keep the demised portion in a neat and habitable condition.
- 4) The LESSEE shall carryout all minor repairs and regular maintenance by way of colour wash etc., at its own cost.
- 5) The LESSEE shall utilize the demised portion for his residence, but shall not use the said portion for any illegal activity.
- 6) The LESSEE shall not sub-let any portion of the premises or transfer the rights under this Lease in favour of anyone.
- 7) The LESSEE shall enhance the rent by 6% compound at the end of every year.
- 8) The LESSEE shall permit the LESSORS or anyone authorized by it, to inspect the demised portion at all reasonable hours of the day.

# THE LESSORS HEREBY COVENANTS AS UNDER:

- 1. The LESSOR shall pay the property taxes pertaining to the leased premises.
- 2. The LESSORS agree not to cause any hindrance to the LESSEES in the enjoyment of the demised portion provided the LESSEE observes all the covenants without default as specified above.
- 3. The LESSORS agree to allow the LESSEE to remove the electrical fittings, false ceiling, air conditioning and any other such system that the LESSEE has installed at their own cost at the time of vacating the floor on the expiry of the lease, or on termination of the lease.
