3. Accordingly the said show cause notice with reference to for further adjudication process at para 8 may be read as

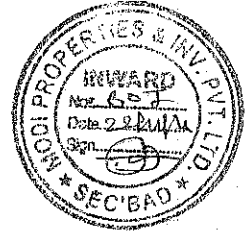
**“Assistant/ Deputy Commissioner of Service Tax, Division II,
