During scrutiny of the following ST 3 returns pertaining to JMKGEC REALTORS PRIVATE LIMITED bearing STC NO. AACCJ3243PSD002, the following discrepancies were noticed.

- i) ST 3 Return for the period October to March, 2015-16: - The Challan Number { 63602192801201630310 } for {Rs.45859/-} in H1 section does not exist and/or is not matching with the Registration Number available in the database; and there is a delay of 83 days in filing of ST 3 Return for which late fee not paid. Requested to pay immediately.

During scrutiny of the following ST 3 returns pertaining M/S JAYANTHILAL SHARAD KUMAR KADAKIA bearing STC NO. ACBPK9161FSD001, the following discrepancy is noticed.

- 1. i) ST 3 Return for the period July to September, 2012-13: Sum of SHE Cess payable {Rs.0/-} entered by the assessee is less than the sum of SHE Cess payable {Rs.4024/-} calculated by the system. Differential amount of Rs.4024/- to be paid immediately and copy of challan so paid may please be submitted.
- ii) 104 days delay in filing of return for the above period, Rs.10,400/- late fee to be paid immediately and submit copy of Challan so paid.
- 2. i) ST 3 Return for the period **April to September, 2013-14**: 06 days delay in filing of return for the above period, Rs. 500/- late fee to be paid immediately and submit copy of Challan so paid.
