NOTIFICATION OF APPROVAL OF THE ORDER OF REGULARISATION OF THE BUILDING IN P.NO.5-9-110/401 TO 404, CHIRAG ALI LANE, HYDERABAD.

The Government of the State of Andhra Pradesh, by the Commissioner & Special Officer, Municipal Corporation of Hyderabad, do hereby give notice that the following building has been regularised under the provisions of the Zoning Regulations, 1981, and the same is now in accordance with the provisions of the Zoning Regulations, 1981.

O R D E R:

The Government hereby relaxes the following Zoning Regulations to the extent indicated below in favour of M/s.Modi Builders for regularization of Construction of 4th floor over the existing building in P.No.5-9-110/401 to 404, Chirag Ali Lane, Hyderabad, Since the cost of the land surrendered by the party Rs.53,49,500/- is more than the penal amount payable by the applicant i.e. 14,27,360/-, the party need not pay any penal amount:

1. F.S.I. : To an extent of 1:0.10 so as to allow an FSI of 1:2.0 against the already permitted FSI of 1:1.9.
2. Side Set Back (S) : To an extent of 0' - 0" to 13' - 0" so as to provide a set back of 29' - 3" to 0' - 6" against the required set back of 26' - 6".
3. Parking space : To an extent of 1120 sft so as to allow a parking space of 11,610.42 sft against the required parking space of 12,738.42 sft.
4. Height of the Building: To an extent of 10' - 0" so as to allow a height of 59' - 3" against the permissible height of 49' - 3".

2. The relaxations accorded at para 1 above are subject to the condition that the applicant should surrender the land affected in road widening free of cost to Municipal Corporation of Hyderabad and they should not claim any compensation in future.

3. The Commissioner and Special Officer, Municipal Corporation of Hyderabad is requested to take necessary further action in the matter.
