SHOW-CAUSE NOTICE

**Sub:** TSPCB – RO-Medchal –Operating Building Construction Project without obtaining Consent for Operation (CFO) of the Board as required under Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and control of pollution) Act, 1981 and amendments thereof – **SHOW CAUSE NOTICE– ISSUED–** Reg.

**WHEREAS** you are operating the building construction project in the name of M/s. Vista Homes, Sy.Nos. 193, 194 & 195, Kapra (V), Keesara (M), Medchal-Malkajgiri District

**WHEREAS** you have obtained the Consent for Establishment of the Board for the above project vide reference 2<sup>nd</sup> cited above as required under Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and control of pollution) Act, 1981 and amendments thereof.

**WHEREAS** as per the condition stipulated in the CFE order, the project has to obtain Consent for Operation (CFO) of the Board once the occupancy of the project begins under Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and control of pollution) Act, 1981. However, you have not yet obtained Consent for Operation of the Board.

**WHEREAS** the Board officials have inspected your project site and the surrounding areas on 05.11.2018 and observed the following:

- ① You have commissioned the project and started occupancy without obtaining the CFO of the Board.
- ② You have not provided S.T.P to treat the domestic effluents.

In view of the above, you are hereby directed to **SHOW CAUSE** as to why action shall not be initiated against you for operating the project without obtaining CFO of the Board. Your reply if any, shall reach this Office within three (3) days from the date of receipt of this notice, failing which, action shall be initiated against your project under Section 33 (A) of Water (Prevention and Control of Pollution) Amendment Act, 1988 and under Section 31 (A) of Air (Prevention and Control of Pollution) Amendment Act, 1987, including disconnection of power supply and closure of your project in the interest of safeguarding Public Health and Environment.
