The terms 'THE VENDUR' and 'THE PURCHASER' herein used shall wherever the context so admits mean and include their respective heirs, executors, successors, legal representatives, administrators and assignees etc., as the parties themselves.

WHEREAS the Vendor is the sole and absolute counter of the Agricultural Land bearing Survey No.144, admeasuring Ac.0-11.5 Gts., Situated at Chinna Cherlapally Village, Ghatkesar Mandal, Ranga Reddy District, by virtue of Pattedar, Vide Patta No.85, Pass Book No.114679, and title deed No.276279.issued at Mandal Revenue Office, Ghatkesar Mandal, R.R.Dist.

The Purchaser agreed to act in the name and on behalf of the Vendor as Agent of the Vendor.

The Vendor hereby authorises the said purchaser to do the following acts in the name and on behalf of the Vendor namely:-

To enter into sub contract for the sale of the said property for any consideration which he deems reasonable in his absolute discretion and receive the earnest money and acknowledge the receipt of the same.






