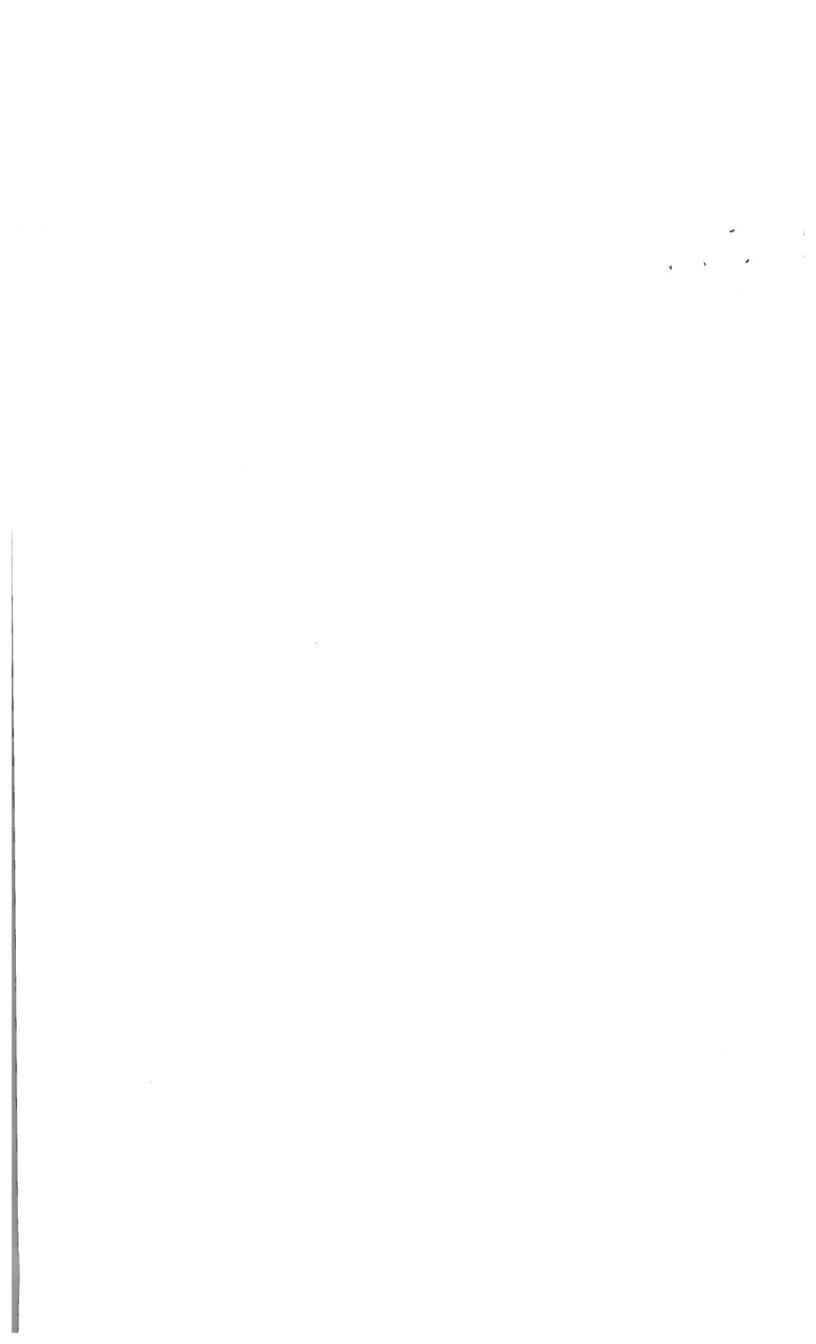
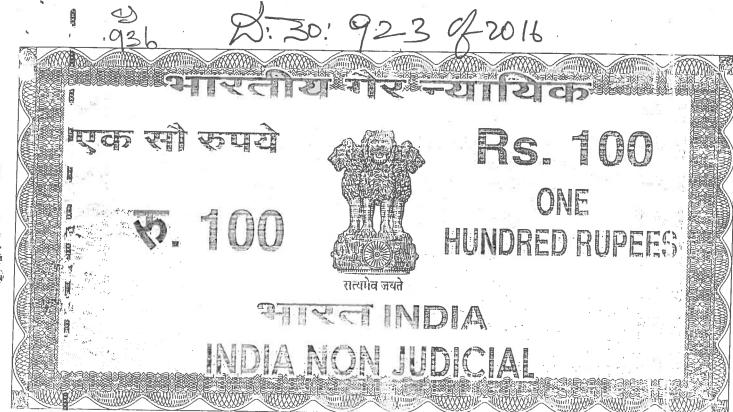

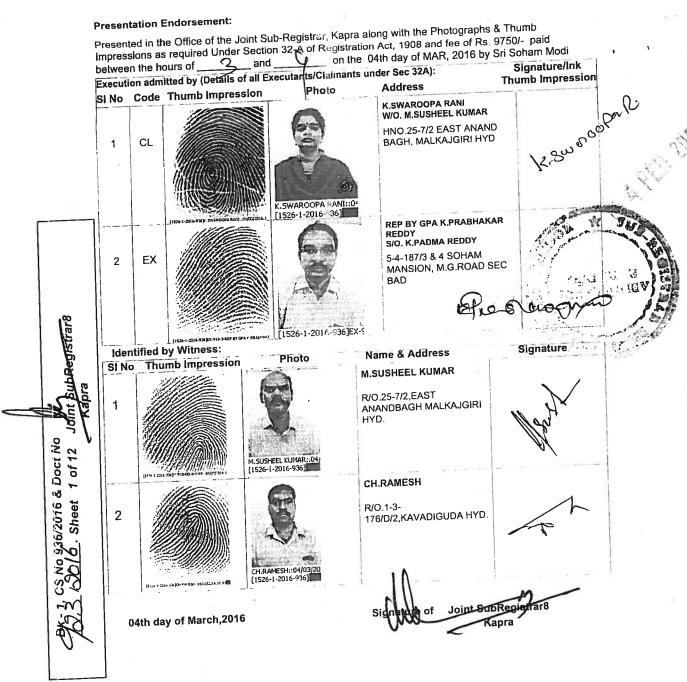

## WHEREAS:

- A. - D. - 2. - iii.
