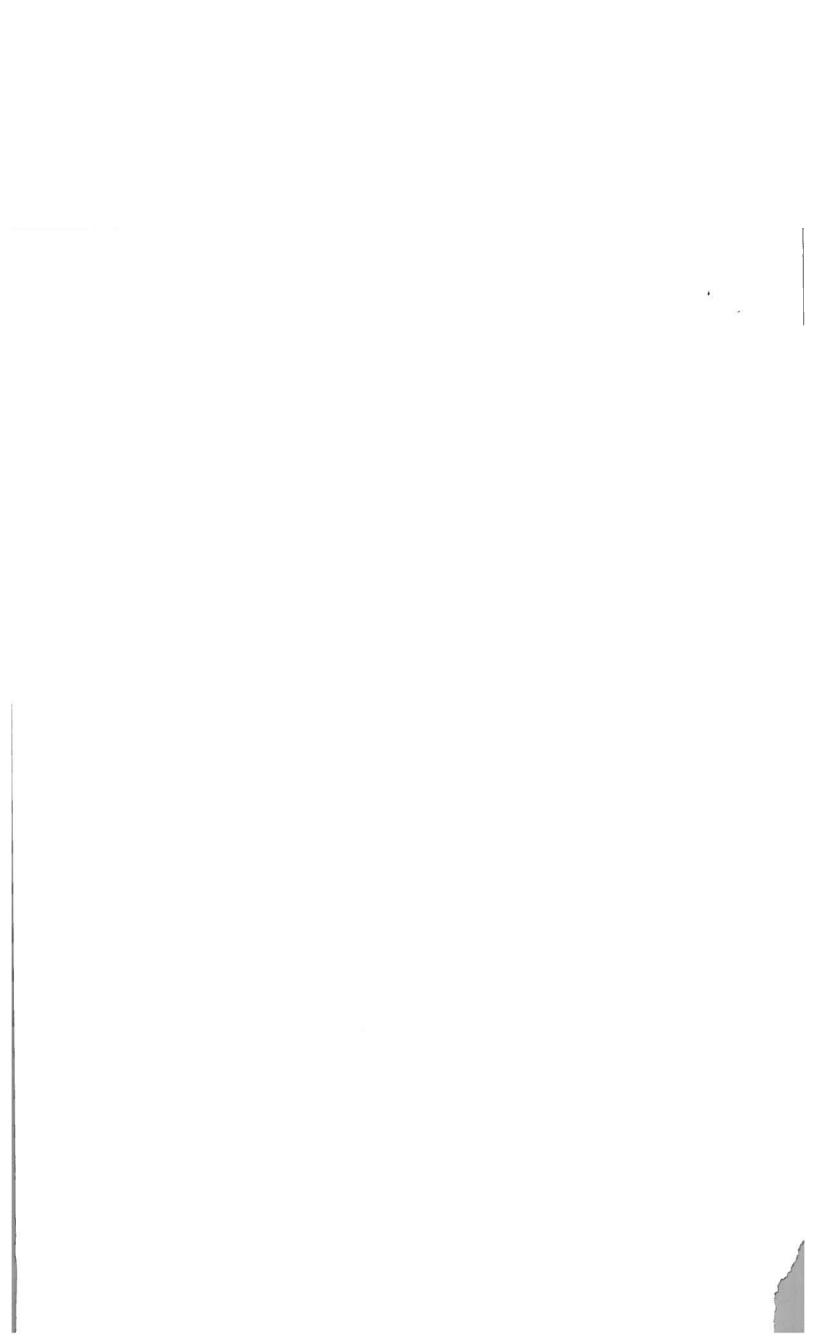
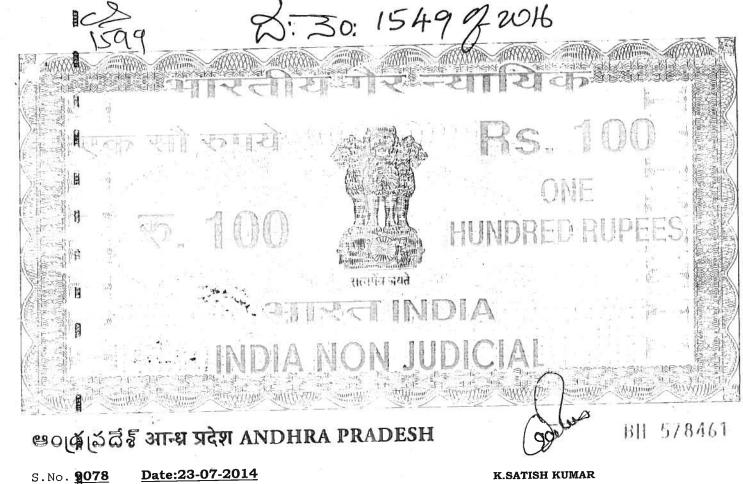

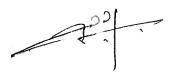


NOW THEREFORE THIS SALE DEED WITNESSETH AS FOLOWS:
