ORDER :

In view of the facts submitted by the applicant and on the strength of the report submitted by the S.H.O: Ghatkeshar vide reference 1st cited and on remittance of Application fee of Rs.500/- (Rupees Five hundred only) remitted vide Challan bearing No. 77287, dated. 07.12.2004 and consideration fee of Rs. 1200/- (Rupees Twelve Hundreds only) vide Challan brg No.97170, dated.01.02.2005 at SBH, Gruhakaalpa branch, Nampally, Hyderabad, the applicant is permitted to cut down (8) toddy trees existing in the premises at Sy.No.s 35 to 39, Cherlapally- village of Ghatkeshar Mandal, Ranga Reddy District, subject to the following conditions under Sub-Rule(5) (Form 11 (b)) of Rule 24 of A.P. Water, Land and Trees Rules, 2002, namely :-

1. Premises of felling tree/ trees is as mentioned as above only.
2. Number of tree / trees permitted to be felled is (8) Toddy Trees only
(Specify species and Number)
3. (160) No.of Plants shall be planted within (30) days of the felling.
4. In case of failure to take up plantation, plants shall be raised at the cost of the applicant.
