**WHEREAS:**

- A) Whereas Shri. Pirangi Rajaiah S/o. Shri. Pirangi Yadaiah was absolute owner and possessor of land admeasuring Ac. 0-14 gts., forming a part of survey nos. 75, 77, 78, 79 & 96, of Rampally Village, Keesara Mandal, Ranga Reddy District (herein after referred to as the Scheduled Property which is more fully described in the schedule given hereunder) having got by virtue of partition deed bearing document no. 3745/05 dated 15.06.2005 registered at SRO, Shamirpet, R.R.
