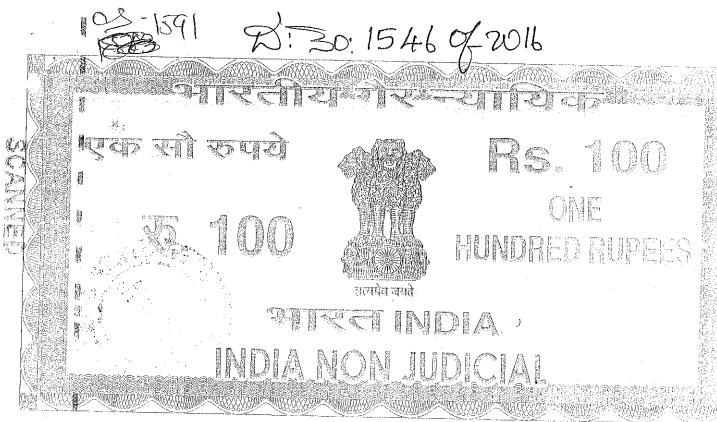

## **WHEREAS:**

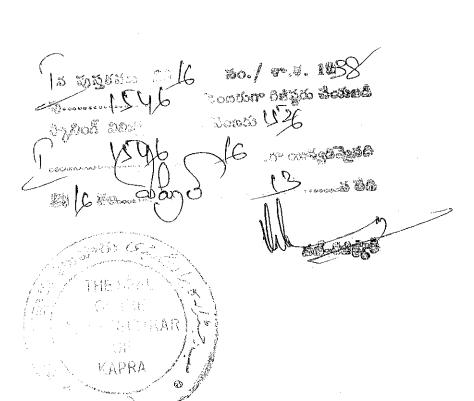

- C. 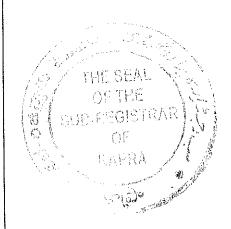

- 9. The Vendee do hereby covenant with the Vendor and through the Vendor with other owners of tenements in Paramount Avenue as follows:
  - i. 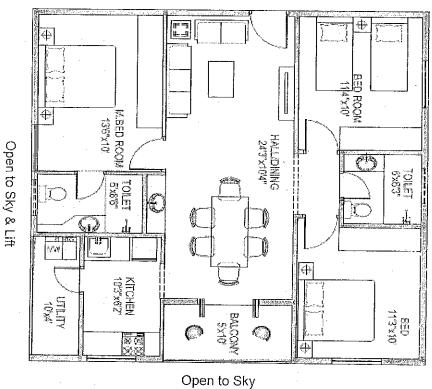

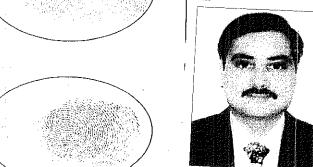

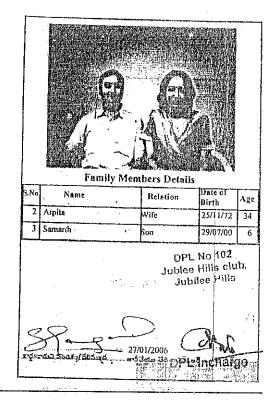
