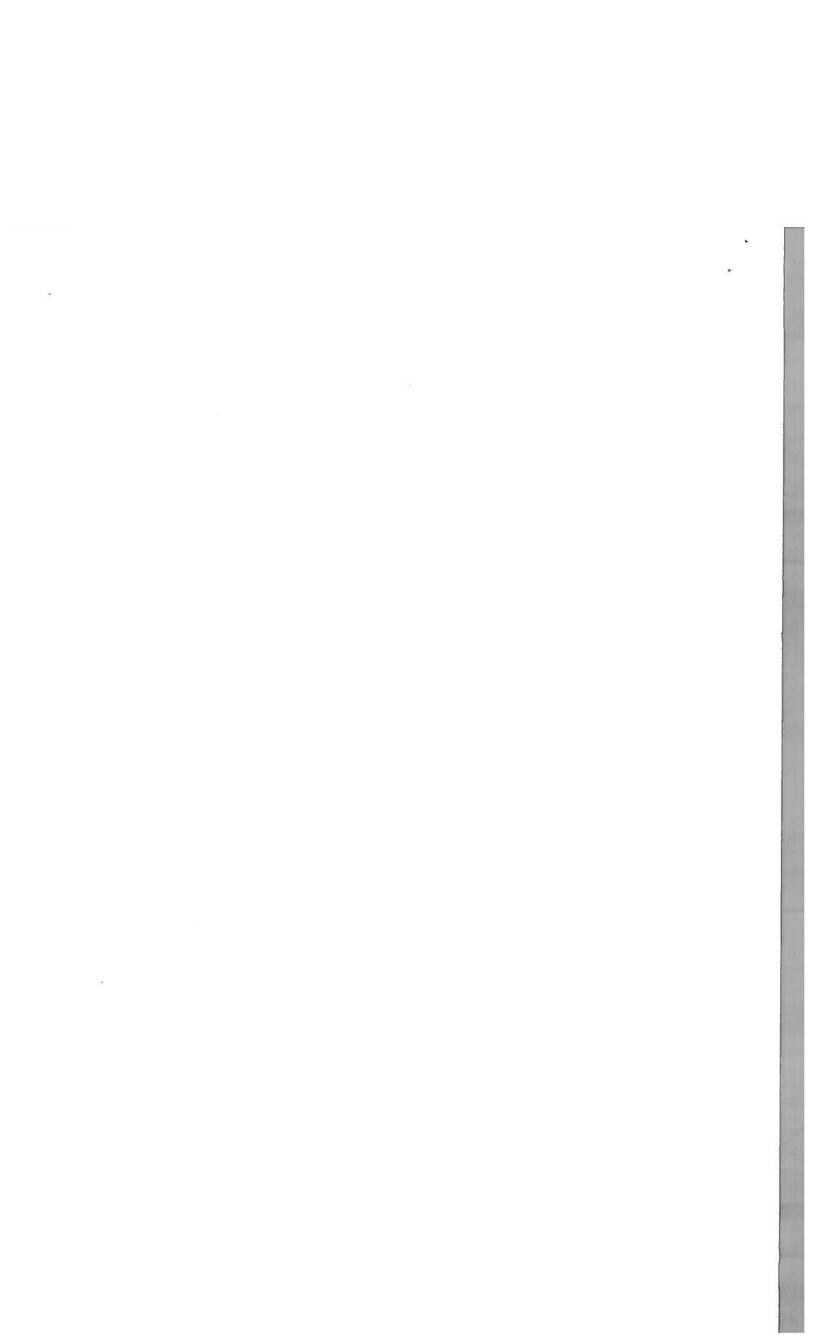
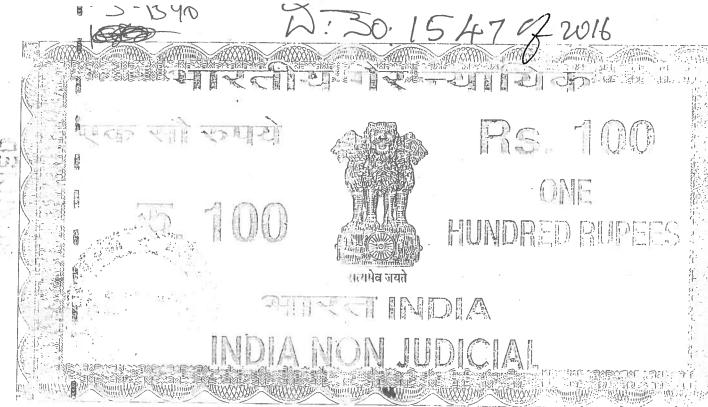

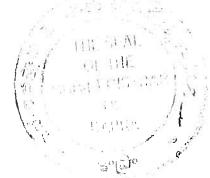

- D.
