

WHEREAS:

- A) The VENDOR is the sole and absolute owner and possessor of open plot no. 264 forming a part in Survey No. 291, admeasuring about 200 Sq. yards situated at Cherlapally Village, Kapra Municipality, Ghatkesar Mandal, Ranga Reddy District, by virtue of Regd. Doct. No. 7811/2006, dated 24th May 2006, registered at the office of the Sub-Registrar, Uppal, Ranga Reddy District.
- B) WHEREAS the Vendor has offered to sell the above said land admeasuring 200 Sq. yds., marked as Plot no. 264 of Cherelapally Village free from encumbrances for a total consideration of Rs. 2,00,000/- (Rupees Two Lakhs Only) and the purchaser agreed to purchase the same for the said consideration.

NOW THIS SALE DEED WITNESSETH AS FOLLOWS:-

- 1. The VENDOR do hereby convey, transfer and sell the 'Scheduled Property' being plot No. 264, admeasuring 200 Sq. yds, in Sy. No. 291 of Cherlapally Village, Ghatkesar Mandal, R. R. District, which is hereinafter referred to as the 'Scheduled Property' and more particularly described in the schedule and the plan annexed to this deed of sale, in favour of the PURCHASER for a total sale consideration of Rs. Rs. 2,00,000/- (Rupees Two Lakhs Only) and the vendor hereby acknowledge receipt of the said consideration.
- 2. The Vendor further covenant that the scheduled property is free from all sorts of encumbrances, charges, cess or attachment of whatsoever nature and as such the Vendor hereby give warranty of title. If any claim is made by and person either claiming through the Vendor or otherwise in respect of the scheduled property it shall be the responsibility of the Vendor alone to satisfy such claims.
