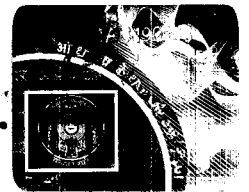

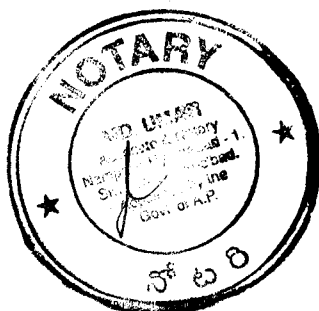

**AFFIDAVIT**

6. That I am fully aware that in the above referred document I and other family members have not been made party to the agreement, though I and other family members have certain rights and interests in the above referred property.
7. That I am one of the beneficiary in the sale consideration of Ra. 4,00,000/- and as such I have also conveyed and sold all my rights, title, interest of whatsoever nature in and over the above referred property though I have not executed the above referred document as one of the co-vendor.

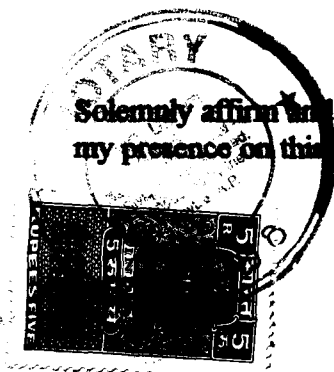
