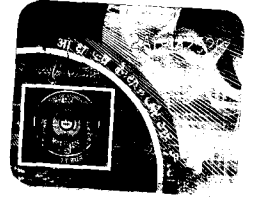

The terms the "CO-VENDORS" and the "PURCHASER" herein used shall wherever the context so admits mean and include their respective heirs, executors, successors, legal representatives, administrators, nominees and assignees etc.,

WHEREAS by virtue of Sale Deed dated 21.06.2000 Sri P. Sanjeeva Reddy, Son of Late P. Sai Reddy sold to the Purchaser dry agricultural land bearing Survey no. 290, admeasuring Ac. 1.00 Gts., or 0.404 Hectres situated at Cherlapally Village, Ghatkesar Mandal, Kapra Municipality, Ranga Reddy District (hereinafter referred to as the scheduled land) ~~for a consideration of Rs. 4,00,000/- (Rupees four lakhs only)~~ This Sale Deed is registered as document no. 5114 of 2000, registered at the office of the Sub-Registrar, Uppal, R. 5. That by executing this ratification deed the co-vendors herein confirm and state that they have no right, title, claim or interest of whatsoever nature in respect of the scheduled land.



