- Whereas a portion of the land, admeasuring about Ac. 0-39 Gts., referred above has been encroached and effected in the existing road. The First Party and the Second Party together are now in possession of the balance land admeasuring about Ac. 17-11 Gts., forming a part of survey nos. 11, 12, 14, 15, 16, 17, 18 & 294, of Cherlapally Village, Ghatkesar Mandal, Ranga Reddy, which is hereinafter referred to as the Scheduled Land and is more fully described in the schedule given herein.
- J) The First Party and the Second Party are desirous of dividing the Scheduled Land into parts by metes and bounds so that each party becomes absolute owner of their share of land and that each party shall hold and enjoy their respective share in the Scheduled Land in exclusion of the other party.
- K) Accordingly both the parties have amicably and mutually agreed to partition the Scheduled Land whereby the First Party shall become the absolute owner of their share of land admeasuring about Ac. 15-37 Gts., forming a part of survey nos. 11, 12, 14, 15, 16, 17, 18 & 294, of Cherlapally Village, and more particularly described in Scheduled A given hereunder and marked in red in the plan enclosed (hereinafter referred to as the Schedule A Land) and the Second Party shall become the absolute owner of about Ac. 1-14 Gts., forming part of Sy. Nos.11, 12, 14, 15, 16, 17, 18 & 294, of Cherlapally Village and more particularly described in Scheduled B given hereunder and marked in blue in the plan enclosed (hereinafter referred to as the Schedule B Land).

The Confirming Party have joined in executing this Partition Deed to assure and ensure the First and Second Parties absolute and peaceful ownership, possession and enjoyment of their respective share of the Scheduled Land, without any let or hindrance from them. The Confirming Party hereby further confirms that they have no right title or interest of whatsoever nature in the Scheduled Land.

M) The parties hereto are desirous of recording the understanding reached amongst themselves with regard to the partition of the Scheduled Land into writing.

NOW THEREFORE THIS PARTITION DEED WITNESSETH AS FOLLOWS:-

- 1. That in pursuance of the said understanding reached and in consideration of mutual consent herein the Scheduled Land is partitioned into two parts by metes and bounds as detailed below:
 - a. First Party shall become the absolute owner of about Ac. 15-37 Gts., forming a part of survey nos. 11, 12, 14, 15, 16, 17, 18 & 294, of Cherlapally Village, and more particularly described in Scheduled A given hereunder and marked in red in the plan enclosed (hereinafter referred to as the Schedule A Land).
 - b. The Second Party shall become the absolute owner of about Ac. 1-14 Gts., forming a part of survey nos. 11, 12, 14, 15, 16, 17, 18 & 294, of Cherlapally Village, and more particularly described in Scheduled A given hereunder and marked in blue in the plan enclosed (hereinafter referred to as the Schedule B Land).
- 2. That in pursuance of the above the First Party hereby grant, convey and transfer all their rights, title and interest in Scheduled B Land unto and in favour of the Second Party to hold the same as sole and absolute owners and the Second Party hereby grant, convey and transfer all their rights, title and interest in Scheduled A Land unto and in favour of the First Party to hold the same as sole and absolute owners.
- 3. That the above said parties shall from this day enjoy the partitioned Scheduled A and Schedule B Land falling to their respective shares without any let or hindrance from the other party and free from all encumbrances.

- 7. The respective parties hereby declare that the Scheduled Land i.e., Scheduled A Land and Schedule B Land is free from all sorts of encumbrances, charges, cess or attachment of whatsoever nature. The parties hereby declare that they have not entered into any agreement or executed any deed prior to this deed with respect to the Scheduled Land. If any claim is made by any person either claiming through the respective parties or otherwise it shall be the responsibility of the respective party alone to satisfy such claims. The parties hereto shall always indemnify and keep indemnified the other for any loss or damage caused on account the deeds and actions of each other. The parties hereby agree that they alone shall be responsible to prove and establish their respective share of ownership in the Scheduled Land (i.e., their flow of title) in the event of any claim or dispute of whatsoever nature that may arise from any third party.
- 8. The parties further declare that there are no rights of any third party relating to any easements, right of way, etc., in respect of the Scheduled Land.
