The SETTLOR undertakes to Cooperate with the SETTLEE in getting his name mutated in the concerned authorities, as its owner and for assessment of property tax, and for such purposes the SETTLOR shall sign all papers necessary.

The SETTLOR undertakes to execute any further deed or deeds in favour of the SETTLEE to perfect his title in respect of the said property hereby gifted.

The SETTLOR undertakes to defend the title of the SETTLEE in case any defect is found or any rival claim is made.

The SETTLOR declares that the SETTLEE shall enjoy the benefits derived out of the said property and has absolute right to alienate, mortgage, gift, sale the same which is left to her discretion.

The SETTLOR declares that the SETTLOR has valid, subsisting title to gift the said property to the SETTLEE and none else.

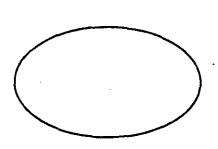
