The plaintiffs submit as follows:-

1. Father of plaintiffs late Sri Eega Pentaiah was a protected tenant in respect of lands in old sy.No.102 corresponding to new sy.nos.11, 12, 14 and 18 part admeasuring Ac 6-00 gts situated at Cherlapally village, ghatkesar mandal RR Dist. During the lifetime of late Sri Eega Pentaiah he has been cultivating the said land as a protected tenant. Sri Eega Pentaiah died on _____ at _____leaving behind the plaintiffs herein as his only legal heirs. Other than the plaintiffs there are no other legal heirs of late Sri Eega Pentaiah. Xerox copy of extract of PT register is filed herewith and marked as document No.1. Original death certificate issued by the concerned authorities is filed herewith and marked as document No.2.

2. Originally the lands in old sy.no.102 corresponding to new sy.nos.11, 12, 14 and 18 part situated at Cherlapally village, ghatkesar mandal RR Dist belonged to late Sri P Sai Reddy, late Linga Reddy and Narsa Reddy, Father of plaintiffs was relativating the

said land as a protected tenant. After the death of late Eega Pentaiah it is the plaintiffs alone who are entitled to succeed to tenancy rights of their late father.

3. After the death of Eega Pentaiah, the plaintiffs have not been cultivating the said lands as there was no water resources for the purpose of cultivation. Moreover the plaintiffs are otherwise preoccupied and as such have decided to surrender the tenancy rights in favour of the legal heirs of original pattedars before the concerned Tahsildar Ghakesar mandal RR Dist. The plaintiffs had approached the Mandal Revenue Officer for issuance of succession in respect of the tenancy rights under section 40 of A.P. Telengana Area, Tenancy & Agricultural lands Act 1950 on . However, the Mandal Revenue Officer has refused to receive the application and to entertain the same on the ground that in view of orders passed by the Hon'ble High Court of AP in writ petition, a legal heirs certificate has to be obtained by approaching Civil Court. The plaintiffs are advised to state that for surrender of tenancy rights in favour of the pattedars, it is necessary to obtain relief of declaration declaring that the plaintiffs are the only legal heirs of late Sri Eega Pentaiah. It is in the said circumstances that the plaintiffs have approached this Hon'ble Court. Hence this suit.

JURISDICTION

The deceased Eega Pentaiah was a permanent resident of Cherlapally village, Ghatkesar mandal RR Dist within the jurisdiction of this Hon'ble Court. This court, therefore, has jurisdiction to try the suit.

CAUSE OF ACTION

The cause of action arose on when late Eega Pentaiah passed away leaving behind the plaintiffs as his only legal heirs. It also arose on when the Mandal Revenue Officer refused to entertain the application for succession under section 40 of the Act. The suit, therefore, is within limitation.

LIMITATION;

- Mandal Revenue Officer has refused to entertain the application for succession under section 40 of the Act on . The suit, therefore, is within limitation.






