WHEREAS:

- A) Smt. Pathika B Bhatt, Wife of Shri. Bhaskar K Bhatt is the absolute owner and possessor of agricultural land admeasuring about Ac. 1-09 Gts., forming a part of Sy. 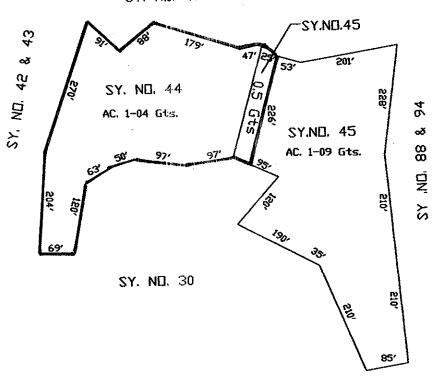
