DEED OF REVOCATION OF GENERAL POWER OF ATTORNEY

This Deed of Revocation of General Power of Attorney is made and executed on this 20th day of June 2006 by:

SMT. V. SUSHEELA, WIFE OF V. V. SUBBA RAO, aged about 40 years, occupation: Housewife, resident of Cherlapally Village, Ghatkesar Mandal, R. R. District, hereinafter referred to as the 'Principal'.

SRI B. BALA CHANDRA MOULI, SON OF SRI SUBBA RAO, aged about 50 years, Occupation: Govt. Service, resident of H. No. B23/1, DAE Colony, ECIL Post, Hyderabad - 500 762, hereinafter referred to as the 'Attorney and Agent'.

1. The Principal has appointed Sri B. Bala Chandra Mouli, son of Sri Subba Rao, resident of H. Bala Chandra Mouli the attorney and the agent of the Principal further declares and states that as attorney holder and as agent of the Principal, he has no claim, title, right, interest of whatsoever nature in respect of the scheduled plot and he has no objection of whatsoever nature in Principal revoking and canceling the above referred General Power of Attorney.
