conditions under Sub-Rule(5)(Form 11 (b)) of Rule 24 of A.P. Water, Land and Trees Rules,
2002, namely :-

1. Premises of felling tree/ trees is as mentioned as above only.
2. Number of tree / trees permitted to be felled is (7) Toddy Trees only
(Specify species and Number)
3. (70) No.of Plants shall be planted within (30) days of the felling.
4. In case of failure to take up plantation, plants shall be raised at the cost of the
applicant.


