Following notification shall be published in the Extraordinary Gazette of Andhra Pradesh dated 5.9.2008.

NOTIFICATION

In exercise of the powers conferred under Section 326 of the A.P. Municipalities Act 1965 and Sub Section (1) of Section 44 of the A.P. Town Planning Act, 1920, the following amendment shall be issued to Andhra Pradesh Municipalities Development Control Rules 2008, issued in the G.O. read above.

AMENDMENT

In Rule 5 (b) (iii) the following shall be added:

“out of which, 9mts from the FTL shall be maintained as green buffer zone and the balance buffer zone can be treated as part of the mandatory setback. In case the required setback is less than the balance buffer zone the difference of the same can be treated as part of the setback transferred from the other sides except front side subject to compliance of fire safety requirements”


