## ORDER:

Whereas in the reference last read above, it was represented that the innovative and people friendly building norms introduced in the G.O.3<sup>rd</sup> read above have not been extended to Jubilee Hills and Banjara Hills areas and requested to extend "the Hyderabad Revised Building Rules 2006" to the said area and to permit residential buildings upto a height of 15 meters without FSI restrictions in view of the high cost of land.

Government after careful examination of the matter and in view of rising land cost in Jubilee Hills and Banjara Hills areas and to mitigate the hardship to plot owners of the said areas, the following amendment is issued to G.OMs.No.86 MA&UD (M1)Dept., Dated 03-03-2006

#### **NOTIFICATION**

In exercise of the powers conferred under Section 585 read with 592 of the Hyderabad Municipal Corporation Act, 1955 and proviso under Sub-Section (1) read with sub-section (2) of Section 14, 32, 46 and 58 of the Andhra Pradesh Urban Areas (Development) Act, 1975, the following amendment shall be issued to "the Hyderabad Revised Building Rules 2006" issued the G.O.3<sup>rd</sup> read above:

#### **AMENDMENT**

The Rule 5 (g)(i) shall be substituted as follows:

"(g) (i). In case of Banjara Hills and Jubilee Hills areas the provisions of G.O. 3<sup>rd</sup> as amended in the references 4 to 11 read above shall be applicable, subject to a height ceiling of 15 meters for both residential and commercial buildings. The height beyond 10 meters in these areas shall be permitted only if the plots abuts to minimum 40 feet wide road.

The above provision shall not be applicable to Apartment complexes.
