 - c) Proceedings in accordance with Sec. 222 to 229, 241 and 232 of the I.T. Act shall be taken for recovery of the amount due.

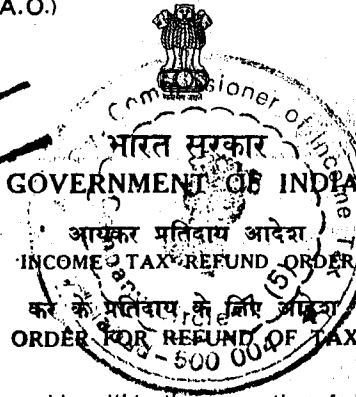
