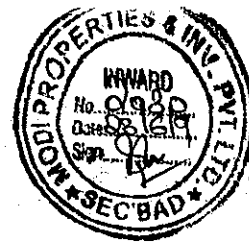


Sirs/Madam;
