The complainant respectfully submits as follows:

6. Facts of the case

- 1. a) The Complainant is a Trust represented by its Trustee Mr.Soham Modi.

 The trust is the owner of several shops in the building known as "21st Centenary Commercial Complex", bearing Shop Nos.5-8-112 to 173/2, 3, 34, 35, 36, 37, 38 and 39, 46 to 51, Adjacent to Old Latha Talkies, Nampally, Hyderabad.
 - b) The Accused Mr.Syed Javeed and his brother namely Syed Khaleed obtained six shops bearing Nos.37, 38, 39, 46, 47 and 58 on rent from

the Trust vide Lease Agreement dated 8.10.1998. They have run business in the above shops till 14th October, 2001 and have vacated all the six shops under their occupation and handed over the possession of the above said six shops to the Trust vide their letter dated 14.10.2001. Since then all the above shops are in possession of the Complainant and the Complainant kept the above shops under lock and key and the Complainant is using those shops whenever necessary for its purpose.

- c). The Complainant further submits that on 2.4.2009, the Accused herein broke open the locks of shops bearing Nos.39 and 46 and occupied the above said two shops illegally and thus committed criminal trespass and other offences of the property of the Complainant Trust. This fact came to the knowledge of the Complainant when the Complainant's employee Mr.Srinivas Reddy inspected the premises in his routine duty on 02.04.2009 about 4 p.m. The employee of the Complainant immediately reported the same to the Complainant. The Complainant questioned the accused for his illegal acts, upon which the accused behaved in an intimidating manner and threatened the complainant's staff of dire consequences if they tried to interfere in his illegal acts. The Accused not only refused to vacate the premises but also threatened the Trustee of the Complainant of bodily harm.
- d). The said act of breaking open the locks and illegally entering the premises, without any right, title or interest and refusing to vacate the said premises, and threatening the complainant's staff of dire consequences clearly shows that the Accused has committed House Breaking, Criminal Trespass and Criminal intimidation.

e) The Complainant approached the P.S. Nampally with regard to the

deliberate acts of the Accused, but the police refused to register the case.

Hence the complainant is constrained to approach this Hon'ble Court for

Justice.

f). The Complainant left with no other option is approaching this Hon'ble

Court to take judicial notice and cognizance of the offences committed by

the Accused U/s 442, 445 and 506 of I.P.C. The offences committed by

the Accused squarely comes u/s 442 and 445 of I.P.C. Therefore, the

Accused is liable to be punished for the offences.

g). The property in which the Accused committed the above offences is

located within the territorial jurisdiction of Nampally P.S. Hence this

Hon'ble court has jurisdiction to try this case.

It is, therefore, prayed that this Hon'ble court be pleased to issue

summons to Accused U/s 204 of Cr.P.C. by taking cognizance of the above

complaint or in the alternative refer the matter to the Station House Officer,

Nampally P.S. Hyderabad U/s 156 (3) of Cr.P.C. for investigation

It is, therefore prayed that this Hon'ble Court may be pleased to punish

the Accused for the offences U/s 442, 445 & 506 of I.P.C for House Trespass,

House Breaking and Criminal Intimidation and pass such other order or

orders as this Hon'ble Court may deems fit and proper in the circumstances

of the case.
