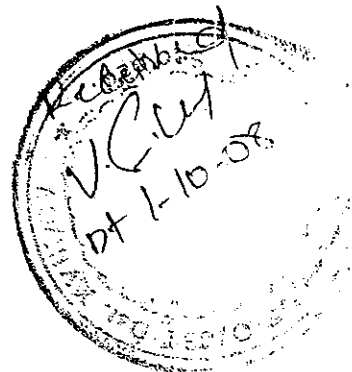
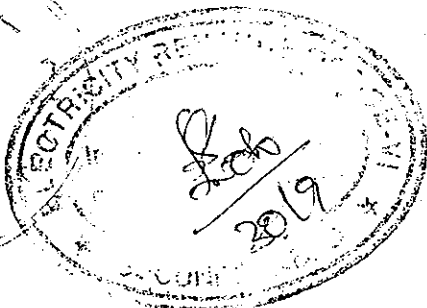
Sir,
