Further, it is inform you that they have paid Rs. 25,000/- to get the stay order and it is your duty to collect the amount from the court.

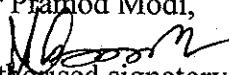

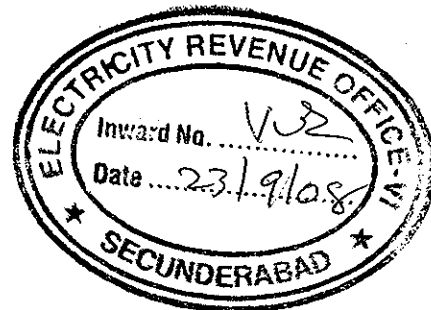
