

Mehta, S/o Late Sri Uttamlal Mehta, aged about 56 years, Occupation: Business, hereinafter referred to as the Builder (which germ shall mean and include its successors in office, administrators, executors / nominees / assignee etc.) IN FAVOUR OF Mr. Kantamneni Venkat Rao, son of Mr. Kantamneni Gopal Rao, aged about 50 Mrs. Jyothirmayi, wife of Mr. Kantamneni Venkat Rao, aged about 39 years, Both are residing 105, Shivakailash Apartments, Yellareddyguda, Ameerpet, Hyderabad, hereinafter referred to as the Buyer (which term shall mean and include his / her heirs, legal representatives, administrators, executors, successor in interest, assignee, etc). WHEREAS:
