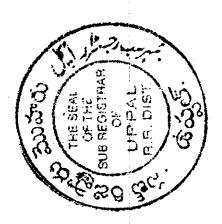

#### WHEREAS:

The Buyer as stated above had already purchased the semi-finished apartment bearing no. 410 on fourth floor in Block 'A' and the parties hereto have specifically agreed that this construction agreement and the Sale Deed referred herein above are and shall be interdependent and co-existing agreements.
- D. The parties hereto after discussions and negotiations have reached certain understandings, terms and conditions etc., for the completion of construction of the scheduled apartment and are desirous of recording the same into writing.

# NOW THEREFORE THIS AGREEMENT FOR CONSTRUCTION WITNESSETH AS

- 1. The Builder shall complete the construction for the Buyer a standard apartment bearing no. 410 on the fourth floor in block no. 'A' admeasuring 485 sft. of super built up area and undivided share of land to the extent of 29.83 sq. yds A reserved two wheeler parking bearing no. 55 admeasuring 15 sft. as per the plans annexed hereto and the specifications given hereunder for a consideration of Rs. 1,33,000/- (Rupees One Lakh Thirty Three Thousand Only).
- 2. The Buyer shall pay to the Builder the above said consideration of Rs. 1,33,000/-(Rupees One Lakh Thirty Three Thousand Only) on or before 31st December 2007.

- 5. The Buyer has handed over the vacant and peaceful possession of the semi-finished apartment bearing no. 410 on fourth floor in Block 'A' to the Builder for the purposes of completion of construction of the apartment.
- 6. The Builder shall construct the Apartment in accordance with the plans and designs and as per specifications annexed hereto. Cost of any additions and alterations made over and above the specifications at the request of the Buyer shall be charged extra.
- 7. The Builder shall be liable to pay all such amounts for and on behalf of the Buyer as may be required by concerned government / quasi government departments for water & by the Builder.
- 8. The Builder shall complete the construction of the Apartment and handover possession of the same by 31<sup>st</sup> December 2007 provided the Buyer fulfils all his obligations under this agreement. The Builder upon completion of construction of the Apartment shall intimate to the Buyer the same at his last known address and the Buyer shall within 15 days of such intimation take possession of the Apartment provided however, that the Buyer shall not be entitled to take possession if he / she has not fulfilled the obligations under this agreement. 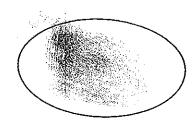

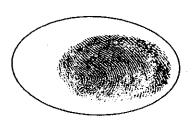

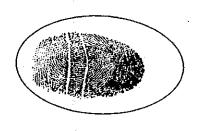
