## NOW THE PARTIES HERETO AGREE AND THIS DEED WITNESSETH AS FOLLOWS.

- 1. The hire charges for equipment, furniture, fittings, fixtures and amenities provided in the premises is Rs. 10,000/- (Rupees ten thousand only). This amount is payable in cash.
- 2. The hire charges for equipment, furniture, fittings, fixtures and amenities stipulated shall be paid to the Landlady by the Tenant on or before the 7<sup>th</sup> day of the calendar month in advance.
- 3. The Landlady shall give the possession of this said equipment, etc., in good condition and order on signing of this agreement.
- 4. The duration of the hire shall be for a period of 11 months commencing from 1<sup>st</sup> of December, 2004. The agreement can be extended for two more terms at an annual escalation of 5% on the basic rent.
- 5. The Landlady or her authorized representative may enter upon the demised premises at the reasonable hours during the day after giving due notice to the Tenant in order to examine the state and condition of the equipment in the demised premises.

- 7. The Tenant agrees to deliver the peaceful possession of equipment, furniture, fittings, fixtures and amenities provided in the premises on the expiry of the hire period covered by this agreement in good condition, reasonable wear and tear accepted.
- 8. This agreement shall be concurrent and coterminous with the Leave and license agreement entered between the same parties for the scheduled premises and stands terminated automatically in the event of the said lease being terminated with the same terms and conditions.
