- The tenancy of the tenant is covered by the profile of a rent control legislation of the state whereby the spant has become a protected tenant under the law.
- 6. The agreement holder has indentified a purchaser for the said premises who is desirous of purchasing of the said property, provided vacant possession of the same is given free of tenants and their manancy rights.

WITNESSET: :

- 1. The tenant has given up its tenancy rights in the said property to the agreement holder and handed over vacant possession thereof to the agreement holder.
- 2. The tenent shall not, hereafter, be a tenant either of the Trust referred hereinabove or of agreement holder will respect to the said property. The tenant shall also not claim, in any manner and before any person or authority, protection under cent control laws nor shall it claim or hold out to be a tenant of the property in any manner.
- 3. The agreement holder has permitted only as a matter of convenience and on its request, the tenant, to use the premises for a short time, temporarily. It is clearly agreed between the parties hereto that the tenant sing the property under the arrangement of this clause shall not be in the character of a tenant but only as an accommodated party.
