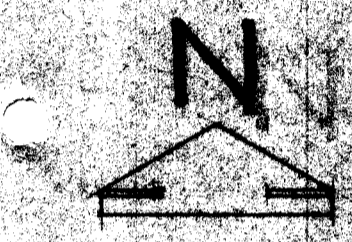


PLAN SHOWING THE LAYOUT OF

 AT RASOOL PURA, SECTOR 14, ABAD.

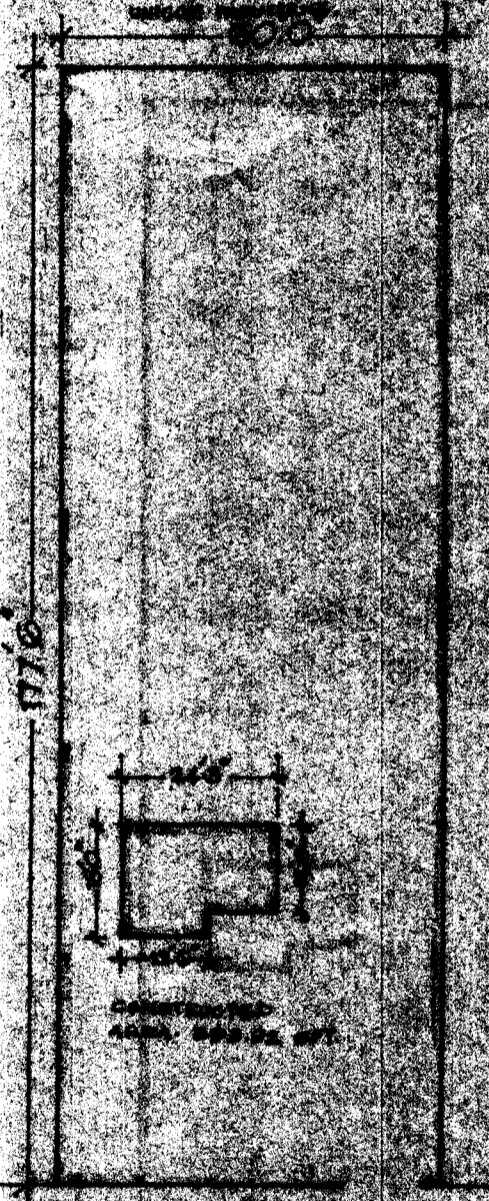
