Brief facts of the case are that, today i.e on 22-9-2005 at 1300 hrs, the complainant Sri P. Sudarshan S/o. Late Pentiah, Age 50 yrs Occ: Business R/o. 1-4-395 Musheerabad, Hyderabad came to PS and lodged a complaint, in which he stated that, he is a Registered GPA and Agreement holder of Survey No. 37, Vallabh Nagar, Balanagar Mandal vide document No. 153/84 from the protected tenants Smt Narasamma W/o. Ramaiah, V. Laxman S/o. V. Ramaiah and V. Yadagiri S/o. Ramaiah. From the year 1984 onwards his name is incorporated in the Revenue Records. But due to involvement of Satish Modi, who was a trust member of Guru Deve Sidhpeeth Ashram, Civil Dispute arose. In the year 1996, in order to avoid civil litigation, they both came to compromise in the presence of Sri Devineni Venkataramana, the then MLA of Nandigama, Krishna Dist. During the year 1996 as such in the said compromise and understanding on 7-3-1996 they both agreed the settlement for on the same day Satish Modi give a sum of Rs 35 lakhs through Cheques and DD towards part payment and promised to pay the balance amount within one year from the date of agreement. But the said Satish Modi has not kept his promise. The said Satish Modi, Suresh Bajaj and Rizwan Shaik Imaam forged his signature in a fabricated document relating to sale agreement as if he paid the full amount to show the public to cheat them besides he cheated him. In such manner they committed criminal breach of trust.

As such on 9-5-1998, he issued a legal notice through his counsel canceling the sale agreement for which Satish Modi has not responded with a reply notice. After the cancellation of said sale agreement Satish Modi, Suresh Bajaj and Rizwan Shaik Imaam with the help of few anti social elements have trespassed into his land tried to make construction. Then he filed an application before Hon'ble Judge, Land Grabbing Court, Hyd vide LGC No. 170/99. The said Suresh Bajaj, in order to counter blast his case, he has filed a writ petition before Hon'ble High Court in vide WP No. 24699/99. The said matters are pending before the respective Hon'ble Courts

As matter stood thus, on 5-6-2005 he came to know through Praveen and Hanumantha Rao, who witnessed that the said Satish Modi Suresh Bajaj and Rizwan Shaik Imaam have conspired together with a dishonest intention to deceive him from his lawful right in the said property have fabricated an agreement dated 7-3-1996, by forging his signature on the said document purported to have been executed between himself and Satish Modi representing on behalf of o Gurudev Siddhapeth as honorary trustee and trying to sell away his property and gain wrongful causing wrongful loss to him to part with the said valuable property W/R nearly about 7 crores. As on date the said persons have also collected huge amounts from the prospective buyers to nearly about 4 to 5 crores and gained wrongfully. Hence the complainant requested for taking necessary legal action against Satish Modi, Suresh Bajaj, Rizwan Shaik Imaam and other anti social elements

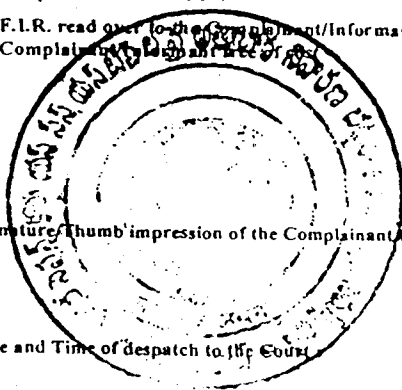

Sub :- Criminal Trespass, Criminal breach of Trust, Cheating & Forgery – committed by Mr. Satish Modi, Mr. Suresh Bajaj & Mr. Rizwan Shaik Imaam – requested necessary Action-Reg.

I, P. Sudharshan, S/o. late Pentaiah, age 50 years, respectfully submit the following few lines for your kind consideration and necessary action.

1. I am a Registered G.P.A. and Agreement holder of survey No. 37, Vallabh Nagar, Balanagar Mandal, vide document No. : 153/84 from the protected tenants Smt. V. Narsamma, W/o. Ramaiah, V.Laxman, S/o. V. Ramaiah and V. Yadagiri, S/o. Ramaiah.
2. From the year 1984 onwards my name is incorporated in the Revenue records. But Due to involvement of Mr. Satish Modi, who was a trust member of Guru Deve Sidhapeeth Ashram, Civil dispute arose. In the year 1996, in order to avoid civil litigation, we both came to a compromise in the presence of Sri. Devineni Venkataramana, the then M.L.A., of Nandigama, Krishna District.
3. During the year 1996 As such in the Said compromise and understanding, on 07.03.1996 we both agreed the settlement for on the same day Mr. Satish Modi give a sum of Rs. 35 lakhs through Cheques and Demand Draft, towards part payment and promised to pay the balance amount within one year from the date of Agreement. But the said Mr. Satish Modi has not kept his promise. The said Mr. Satish Modi, Mr. Suresh bajaj & Mr. Rizwan Shaik Imaam forged my signature in a fabricated document relating to sale agreement as if he paid the full amount to show the public to cheat them besides he cheated me. In such manner they committed criminal beach of trust.
4. As such on 09.05.1998, I have issued a legal notice through my counsel Mr. Sadasivanarayana canceling the sale agreement for which Mr. Satish Modi, has not responded with any notice. After the cancellation of said Sale Agreement Mr. Satish Modi, Mr. Suresh Bajaj and Mr. Rizwan Shail Imaam. With the help of few anti-social elements, have trespassed into my land tried to make construction. Then, I have filed an application before Hon'ble Judge, land Grabbing court, Hyderabad, vide L.G.C. No. 170/99. The said Mr. Suresh Bajaj, in order to counter blast my case, he has filed a writ petition before the Hon'ble High Court in vide W.P.No. 24699/99. The said matters are pending before the respective Hon'ble Courts.

5. As matter stood thus, on 5-6-2005, I came to know through Mr. Praveen and Mr. Hanumantha Rao who witnessed that the said Mr. Satish Modi, Mr. Suresh Bajaj and Mr. Rizwan Shaik Imaam, have conspired together with a dishonest intention to deceive me from my lawful right in the said property, have fabricated an agreement dated 07.03.1996, by forging my signature on the said document purported to have been executed between myself and the said Mr. Satish Modi, representing on behalf of Gurudev Siddhapeth as honorary trustee and trying to sell away my property and gain wrongfully causing wrongful loss to me to part with the said valuable property worth nearly about Rs. 7 crores. As on date the said persons have also collected huge amounts from the prospective buyers to nearly about 4 to 5 crores and gained wrongfully.

Therefore, in the above circumstances, I request your goodself to take necessary action against the said Mr. Satish Modi, Mr Suresh Bajaj, Mr. Rizwan Shaik Imaam and others ^{Social elements} Anti for Criminal trespass, Criminal breach of trust, Cheating and forgery. For the action of which, I shall be ever grateful to you Sir.






