REVISION OF MINIMUM RATES OF WAGES IN THE EMPLOYMENT IN "GOLD COVERING — AND GOLD COATING INDUSTRY" IN PART-I SCHEDULE OF THE MINIMUM WAGES ACT, 1948.

[G.O.Ms.No. 68, Labour, Employment, Training and Factories (Lab-II), 29th November, 2000.]

In exercise of the powers conferred by sub-section (1) of section 3 and sub-section (2) of section 5 of the Minimum Wages Act, 1948 (Central Act 11 of 1948) and of all other powers hereunto enabling and after having consulted the State Minimum Wages Advisory Board, the Governor of Andhra Pradesh hereby fixes the minimum rates of wages which shall consist of basic wage and cost of living allownce as specified in column (3) of the Schedule below as payable to each category of employees specified in the corresponding entry in column (2) thereof and employed in the employment in "Gold Covering and Gold Coating Industry" as specified in part-I of the Schedule of the Minimum Wages Act, 1948 in the State of Andhra Pradesh as the same having been previously published as required under clause (b) of sub-section (1) of section 5 of the said Act.

The Minimum rates of wages so fixed shall come into force with effect from the date of publication of this notification in the Andhra Pradesh Gazette.
