GENERAL AMENITIES AGREEMENT

This GENERAL AMENITIES AGREEMENT executed at Secunderabad, on this the 28th day of February 1998 by and between:-

- 2. Mrs. Kosha S. Dalal, aged 23 years, W/o. Shri. Sangesh Dalal, Residing at. 28, Dwarakadas colony, Mayuri Marg, Begumpet, Hyderabad - 500 020 hereinafter referred to collectively as the "HIREE" (which term shall mean and include whenever the context may so require their successors-in-interest)

The **HIREK** has obtained on lease a portion of about 500 sq. ft. of the ground floor of Modi House bearing Municipal No. 1-10-72/2/3, Begumpet Main Road, Hyderabad - 500 016 from the Owner vide Lease Agreement dated 28th February 1998. At the Request of the **HIREE**, the owner has agreed to provide amenities to the **HIREE** more fully described in the schedule. The **HIREE** has agreed to pay amenities charges for the said amenities apart from the rent payable to the **OWNER**.

NOW THIS DEED WITNESSETH AS UNDER:

- 1. The **HIREE** shall pay amenities charges of Rs. 18,000/-(Rupees Eighteen Thousand Only) per month apart from and along with the rent payable.
- 2. The **HIREE** shall enhance the amenities charges by 8% (eight) compounded at the end of every year.
- 3. The **HIREE** shall pay the amenities charges for each month on or before the fifth day of each calendar month in advance to the **CWNER** or his authorised agent.
- 4. The **HIREE** shall not be entitled to surrender the usage of amenities as long as the tenancy is subsisting.
- 5. Any default in the payment of amenities charges shall be deemed to be a breach of the covenants of tenancy and the **CWNER** shall be entitled to determine the lease and the **HIREE** shall give vacant possession of the tenancy:

PARTICULARS OF AMENITIES :

- 1. Electrical Wiring & Plumbing.
- 2. Provision of door, windows, Steel Shutter.
- 3. Electrical Meter.
- 4. Provision of Electric power connections.
