Under Regulation 12 of the Zoning Regulations, 1981, the Government hereby relax the provisions of Regulation 9.2.5 of the said Regulations to the extent indicated below in favour of Sri M.B.S. Purushotham for the proposed construction of show rooms in the first and second floors on the existing ground floor shops in P.No.1-10-72/1/3 situated at Begumpet, Secunderabad.

Zoning Regulation 9.2.5:

(1) Front open space: (North)

To an extent of 11'-2" so as an open space of 3'-10" is maintained against the required open space of 15'-0".

(2) Rear open space: (South) To the full extent of 10'-0".

(3) Side open space: (West)

To the full extent of 6'-6".

(4) Side open space: (East)

To an extent of 5'-5" so as an open space of 1'-1" is maintained against the required open space of 6'-6".

(5) Parking Space:

To an extent of 688 Sq.ft. so as a parking space of 132 Sq.ft. is provided against the required parking space of 820 Sq.ft.

The Commissioner, Municipal Corporation of Hyderabad is requested to the take necessary action accordingly and issue a building permit to the petitioner.
