ORDER:

The Hakimpet Air Force Authorities have requested the Government to impose special restrictions on constructions in the vicinity of Air Force Station, Hakimpet, as the said station is a training base for fighter pilots and restrictions on constructions would help improve flight safety and help reduce bird menace.

2. The Government after careful examination of the matter in consultation with Vice Chairman, Hyderabad Urban Development Authority decided to prescribe special restrictions for allowing development activity in areas around Air Force Station, Hakimpet. Accordingly the following orders are issued.

Within the 4 Air Funnel Zones as prescribed in the appendix annexed to this order -

- i) The maximum height of buildings shall be 7.0 mts. upto a distance of 1.0 K.M. and 15.0 mts. for the remaining distance of 3.0 K.Ms.
- ii) Within the funnel zones the following uses shall be prohibited.
 - a) butcheries
 - b) tanneries
 - c) refuse dump sites

3. For all other development permissions, special permission shall be obtained from Air Force Authorities in addition to permissions from Local Bodies/Authority.

4. The concerned Competent Authorities are requested to take immediate necessary action to amend the relevant Zoning Regulations/Building Bye-laws etc. suitably.
