Herein after referred as the Parties of the Second Part. . .

Whereas, Late Mohan Parida, Husband of party no.1 of the Parties of the Second part died on 5th September 2007 day at about 6:15 p.m. time at his residence after the duty hours due to electric shock on account of his own negligence / mistake. Late Mohan left behind him the no.1 to 3 parties of the second part as his legal heirs. In a helpless state, Smt. Tikki Parida approached the parties of the first part for a financial help to take care of her children on account of sad untimely demise of her husband Late Mohan Parida. Though the parties of the first part is not under any obligation to pay any compensation or to render any financial assistance/ help to the parties of the second part on any account of whatsoever nature under any of the provisions of Law, as the death of Mr. Mohan Parida is not in the course of employment, the parties of the first part considered the requests of the parties of the second part on humanitarian grounds and accordingly paid an amount Rs. 2,50,000 (Rupees Two Lacs fifty thousand only) to the parties of the second part, subject to the following terms and conditions that are mutually agreed between the parties of the first and second parties.

TERMS AND CONDITIONS


- 1. The Parties of the second part unequivocally declare that the death of Mr. Mohan Parida is after the duty hours and not in the course of employment.
- 2. The parties of the second part declare that they are not entitled for any compensation on account of death of Mr. Mohan Parida under any of the provisions of Law and equally the parties of the first part is neither responsible nor liable for payment of any compensation under any of the provisions of Law, as the death of Mr. Late Mohan Parida is out of the employment after the duty hours.
- 3. The parties of the first part on humanitarian grounds helped the parties of the second part by payment of an amount of Rs. 2,50,000 (Rupees Two lakhs Fifty Thousand only). The parties of the first part has already paid an amount of Rs. 20,000/- and the balance payment is invested in the national Savings Scheme by the parties of the first part against the request of the parties of the second part, in their interest and welfare. Accordingly, the parties of the first part took the following NSS certificates in the name of the parties of the second part for the a above said amount.

The parties of the second part unequivocally declared that they got no legal right to claim any amount form the parties of the first part and further declared that they shall not make any claim of whatsoever nature on whatsoever account against the parties of the first part, as the parties of the first part are not liable to pay any payment / compensation of whatsoever nature on whatsoever account to the parties of the second part.
- 6. The parties of the second part declare that the financial assistance rendered by the parties of the first part is purely on the humanitarian grounds and the same do not confer any right of whatsoever nature to make any claim against the parties of the first part.







- The parties of the second part declare that the contents of this agreement are read over and explained to them in their mother tongue by their relatives and affixing their signatures here under, having understood the contents of this agreement fully.
- 8. The parties of the second part agree that there is no relationship of master and servant between the parties of the first part and the deceased Mr. Mohan Parida.






