



# IN FAVOUR OF

DR. RAMKINKAR SHASTRI SON OF MR. RAMDAYALU SHASTRI aged about 35 years, residing at 201, Venkat Balram Castle, New Mettuguda, Secunderabad - 500017, hereinafter referred to as the "Buyer" (Which expression where the context so permits shall mean and include his/her/their heirs, successors, legal representative, executors, nominee, assignee etc.).

### WHEREAS:

- A. The Vendor is the absolute owner and is possessed of all that land forming a part of Sy. No. 1/1, (Ac. 1-39 Gts.), Sy. No. 191 (Ac. 2-00) & Sy. - F. 


- 3. The Vendor further covenants that the Scheduled Apartment is free from all sorts of encumbrances, charges, cess or attachment of whatsoever nature and as such the Vendor hereby gives warranty of title. - c.
