This is a case filed by the petitioners
Sri B.Sathaiah and B.Yadalaiah sons of Late Sri Veeraiah
Under Rule 10 of the A.P.(T.A) Land Revenue Rules, 1951
over the lands bearing Sy.Nos. 137 (6-39); 224 (0-10) ;
233 (2-30) ; 604 (1-35) situated at Nagaram village,
Keesara Mandal, R.R. District.

The petitioners have filed the following
documents in support of their contention.

The petitioners, Sri Bijja Sathaiah and Bijja -
Yadalaiah were deposed that the lands bearing Sy.Nos.
137, 224, 233, 604 extent 6-39 Acrs; 0-10 Acrs ; 2-30 Gts.
1-35 Gts., situated at Nagaram village stand patta in
the name of Sri B.Maisaiah who is their uncle and
he has left the village about 40 years and where ~~his~~ *his*
address are not known. The Petitions, further stated
their father Sri. Veeraiah was cultivating the above
lands since 1953 by paying land Revenue to the Government
regularly. The petitioners further deposed that their
father expired in the year 1985 and they are only
legal heirs and cultivating the said lands and requested
to grant ownership rights Under Rule 10 of the A.P. (T.A)
Land Revenue Rules, 1951.

On perusal of the certified copies of the pahanies for the years 1985-86; 1984-85; 1965-66; 1977-78; 1978-79; 1968-69; 1959-60; 1962-63; 1981-82; 1961-62; 1980-81; 1979-80; 1966-67; 1958-59; ~~1955-56~~ 1956-57; 1972-73; 1975-76; 1976-77; 1977-78; 1970-71; 1971-72; 1969-70 and Land Revenue Scripts ^{it is evident that the petitioners follow} is in possession and enjoying the Lands by paying the Land Revenue to the Government, as such the petitioners have perfected their respective title by way of adverse possession over the lands bearing Sy.Nos. 137 (6-39); 224 (0-10); 233 (2-30); and 604 (1-35) situated at Nagaram village of Keesara Mandal, R.R.District.
